

- Integrating the transversal theme of gender issues in all areas of our work.




3. ORGANISATIONAL STRUCTURE AND ACTIVITIES

4. REALIZED PROJECTS AND ACTIVITIES IN 2018

4.1 AGRICULTURE AND RURAL DEVELOPMENT

BUILDLAG Project - Strengthening public-private partnership through the operation of Local Action Groups (LAGs) for Sustainable Rural Development

Description of the activity: CeProSARD started its implementation on 19.12.2017 of the project BUILDLAG, financed by the European Union. Within the project, capacity building is being carried out, and the establishment of a new Local Action Group (LAG), which is in line with the country's integration processes in the EU. The goal of the project is to strengthen public-private partnership between rural non-governmental organizations, business associations and local authorities, and thus enable sustainable rural development. The target group of the project are non-governmental organizations, business associations and local authorities in the Polog Planning Region. In 2018, a large part of the envisaged activities were realized as follows: a communication plan was developed, a logo, a banner and a project memo were created, which were approved by the monitoring team from the EU, the General Secretariat and the CFCD; a Steering Committee with five members was appointed (the Center for Development of the Polog Planning Region, the Ministry of Agriculture, Forestry and Water Economy, the Federation of Farmers, the Faculty of Agricultural Sciences and Food and the Economic Chamber of the Republic of Macedonia); informative event and three round tables for CSOs, municipalities and the business sector in the Polog Planning Region were held; the web site of the project was made https://buildlag.mk/ on which all project events are actively presented, which will be transferred to the LAG after the completion of the project; a dedicated workshop for the LEADER program for the needs of the civil society organizations was organized; a study visit was held in Granada - Spain to convey the experience of the partner organization - the association of young farmers Asaja Granada from Spain to all stakeholders in the newly formed LAG; preparation of the legal registration documents



for the LAG has begun. Using the tools for promotion and visibility of the project, the CeProSARD team continuously works on raising public awareness of the advantages of forming LAGs for the promotion of European practices and integrated EU policies.

Inclusion of all affected stakeholders in the project will enable development and their improvement, will encourage partnerships for joint activities and will contribute to the global processes in this area.

Specific objectives:

- To increase knowledge and to strengthen the capacities of civil society and local authorities for the sustainable functioning of LAGs through the transfer of the experience and best practices of the EU;
- Establish a functional partnership between civil society and local authorities in the newly established LAG;
- Provide policy recommendations to promote the LAGs and the benefits of joining them;
- To raise public awareness of the benefits of establishing a LAG and to promote European practices and an integrated EU policy.

4.2 SECTOR FOR LOCAL DEVELOPMENT

Project FRET-STIC- Fostering Rural and Environmental Tourism through Smart Tourist Information Centres

<u>Description of the activity:</u> The main goal of the project is development, and promotion of local and regional tourism through innovative approaches and systems for improving rural and environmental experience. The goal will be achieved through the creation of strategic tools that will enable better understanding of the requirements of the visitors, while serving as mechanisms for enhanced interregional cooperation between different aspects of industry, government institutions, the business sector and civil society organizations that will result in increasing the tourist potential, tailored to the needs of the target groups. In addition, the project aims at creating a favorable



environment for strategic reach and benefit not only from national and regional markets, but also from emerging international markets in the tourism industry.

Specific objectives:

- Establishment of networked, smart Tourist Information Centers (STICs) that can gather, use and create information about tourism potentials in the Shara region;
- Better understanding and presentation of the tourism potentials of the cross-border region, using modern e-systems and mutual cooperation.

Activities:

- Spatial positioning and construction of two STICs in Tetovo and Prizren, as well as the transformation of 2 TICs into smart TICs - Popova Shapka and Prizren;
- Designing standardized business processes and training programs for better understanding of tourists and service
- Digital mapping of infrastructure and events related to rural tourism in the cross-border region of Shara.;
- Creation of promotional materials for promotion of project activities and results;
- Joint cross-border events for sharing and promoting the results of the activity.

Expected results of the project are:

- Networked, smart tourist information centers (STICs) linked to a common platform based on standardized business processes and on existing concepts for Tourism Information Systems (TIS);
- Business processes designed to effectively and efficiently serve tourists through STICs, as well as to collect data about their behavior and preferences. Trained staff from both sides of the region to work in STICs;
- A digital matrix of mapped tourist infrastructure and events in the Shara region has been created, including marked / unmarked hiking trails, signalization, accommodation, restaurants, other important tourist sites and events. The digital matrix will be used by the Iter-Regional Tourist Online Platform (iTOP) to create tourism products for the cross-border region;
- Prepared materials with content to promote cross-border tourism in the Shara region;



 Training of tourist information centers for smart service / data collection for tourist preferences, as well as tourist products created by the matrix.

<u>Target group:</u> municipalities, government agencies responsible for regional development, tourism and culture; civil society organizations; small and medium enterprises; tourism clusters; the Chamber of Commerce and Tourist Information Centers.



Municipal Services Improvement Project (MSIP)

<u>Description of the activity:</u> The CeProSARD 2018 team continued to prepare documents for evaluating municipal projects within the Municipal Services Improvement Project (MSIP); Preparation of feasibility studies for construction of infrastructure projects such as sewage to an



existing water treatment plant in the rural environment, construction and reconstruction of kindergartens, construction of local roads. Developed in 2018 were feasibility studies for the following municipalities:

- Evaluation document for "Reconstruction of streets in the settlement Mesheista" and "Improvement of the capacities of CSE Debrca through procurement of mechanization" in the municipality of Debrca;
- Evaluation document for the project "Construction and reconstruction of the municipal road from the settlement Elevci to the settlement Dolgash" in the municipality Centar Zhupa;
- Evaluation document for the project "Construction, upgrade and reconstruction of an administrative building in the municipality Novo Selo according to the principles of energy efficiency";
- 4. Evaluation document for the project "Reconstruction of the street in the settlement Kadino to the highway A4 in the Municipality of Ilinden";
- 5. Evaluation document for the project "Reconstruction of part of the street" 1 "and floor arrangement in the center of the settlement Studenichane";

4.3 SECTOR FOR RES and EE

Project ZenH Balkan - Towards Zero energy Hospitals in the Balkan Region



<u>Description of the activity:</u> The CeProSARD team in December 2017, within the BalkanMed program, started the implementation of the Towards Zero Energy Hospitals in the Balkan Region (ZenH Balkan) project - Hospitals in the Balkans with energy close to zero. The project aims to facilitate the implementation of the revised Energy Performance of Buildings (EPBD) Directive by defining the characteristics and standards for zero energy hospitals in the South Balkan region. The project will contribute to improving energy efficiency in the construction sector by improving the energy efficiency of hospitals. Hospital buildings are considered complex systems because they have several energy-intensive functions (heating and cooling systems that need to provide strict comfort conditions, high demand for hot water, etc.)..

Expected results:

- Preparation of EE standards and guidelines for ZenH hospitals;
- Improving the technical capacity of professional groups and government officials towards the concept of EE facilities;
- Preparation of detailed analysis and testing of the set up models for improvement of 7
 hospital buildings in near to zero energy buildings NZEB that will be ready to seek
 financial means for implementation of the measures.

Activities:

The project included all 5 countries covered by the BalkanMed program, and activities are distributed in each country. Preliminary – walk-through energy audits will be conducted in different climate areas in the 5 countries, with EU partners focusing mainly on hospitals located in urban areas, while IPA partners will focus on health facilities located in smaller communities. The same approach will apply to standard energy audits. In 2018, the CeProSARD team in cooperation with the Ministry of Health of the Republic of Macedonia selected the hospitals in which energy audit will be carried out. As for the hospitals that will be used as demo case studies, they will be selected on the basis of the highest potential, and not on the basis of regional parameters. The technical guidance that will result from the cooperation of energy audit teams in all countries for hospitals near to zero will apply to the whole region of Southeast Europe, as climate characteristics and construction practices are almost identical in all countries directly supported by BalkanMed program.

Out of the planned 5 trainings for capacity building of the technical staff of the hospitals during the year 2018, three trainings were held on the following topics:



- Energy buildings near to zero & Sustainable smart cities (Nicosia, May 9-11, 2018)
- Heating and cooling with solar energy (Skopje, 19.06.2018)
- Introduction to tools for simulation of energy efficiency of buildings (Sofia, 13-14.11.2018)

The material from the trainings will be available on the project website and on the BalkanMed program.

The project also includes 5 meetings between the partners that will be organized in Xanthi (2), Tirana, Sofia and Skopje. During 2018, 3 coordinative meetings were held:

- Xanthy (13-14.02.2018)
- Skopje (20.06.2018)
- Sofia (14.11.2018)

In the final phase of the project, an international conference hosted by the Xanthi University will be organized, but experts from all over Europe will take part. The international conference and publications published in international journals will expand the scope of the project.

4.4 SECTOR FOR ENVIRONMENT

Project "Support for improved management of natural resources in NP 'Pelister'"

<u>Description of the activity:</u> The goal of the project is "to provide technical support for better management of NP 'Pelister', including monitoring and sustainable use of resources".

Specific objectives:

- Establishment of a system for monitoring large carnivores in NP Pelister in accordance with the national legislation and EU requirements;
- Improving mountain tourism;
- Estimating the potential for ecosystem services related to water.

Activities:

- Monitoring and protection of large carnivores: brown bear (Ursus arctos), lynx (Lynx lynx) and wolf (Canis lupus) as key species according to Annex II of the EU Directive on habitats in the National Park "Pelister" in 2018 10 cameras for the monitoring of wild animals, and training of the Rangers in the National Park Pelister was held;
- Clearing and marking two mountain bike trails in the Park;

Environmental Assessment and Preparation of Integrated Environmental B License for Aradiko Kop DOOEL

Description of the activity:

CeProSARD as environmental consultant prepared an Integrated Ecological License "B" for the needs of Aradiko Kop DOOEL import-export from Rzanichino, Petrovec.



The consulting services that were carried out during the project were divided into two phases: the first stage where an assessment was made of the existing situation and the second phase where the Integrated Pollution Prevention and Control (IPPC) was made with assessment and measurement of pollution emissions. During this phase, the consultants used their own measuring equipment in order to process all input data and to prepare studies and elaborates (setting up the project, performing calculations and draft measures) in their own working premises.

The result of the project is the prepared ENVIRONMENTAL ASSESSMENT AND PREPARATION OF APPLICATION for "B" license for Integrated Pollution Prevention and Control (IPPC). The overall analysis and implementation of the proposed set of measures for the protection and sustainable management of the environment and the obtained data were entered in the template of the document for integrated pollution prevention and control B license in accordance with the Macedonian legislation.

The introduction of the improvement program will have direct positive implications on raising the awareness of the wider public awareness taking into account the diversity of the customers, and, of course, by improving the habits of the employees.




